

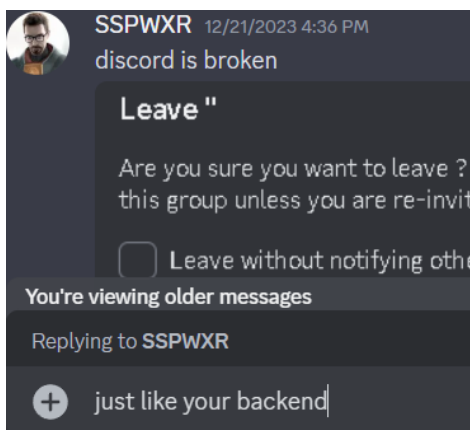
KCN against Hyperion... again

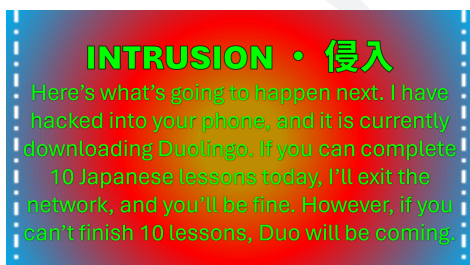

In late December, SSP decided that he was going to depart from the group, forever, and leave related servers, due to BunnyTub making fun of his backend code.

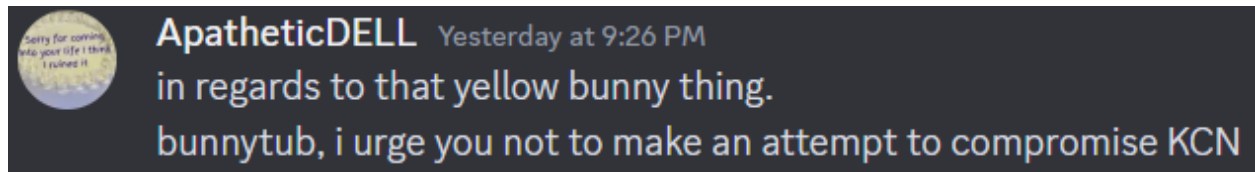


BunnyTub was fine with SSP and Peyton, as they hadn't done anything, and simply apologized. Until the following events occurred.

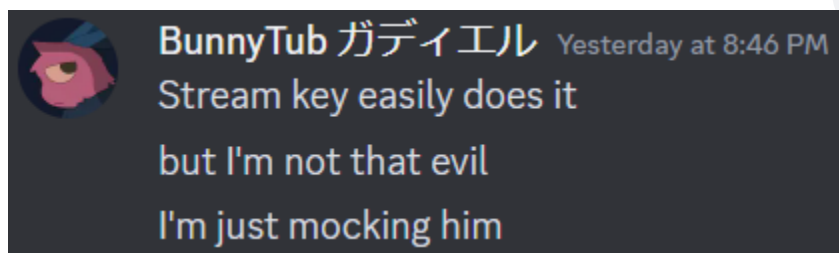

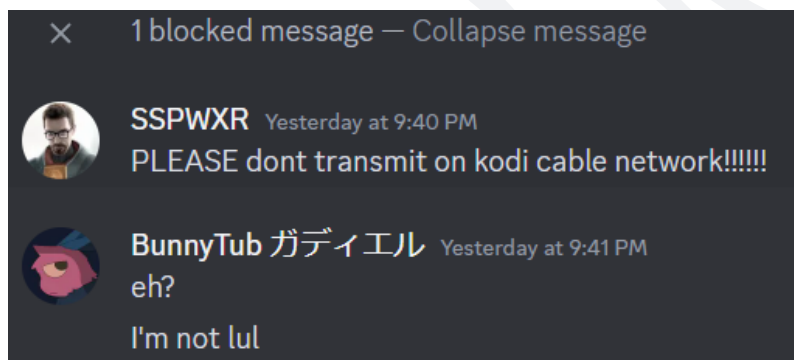

It seems that someone in one of BunnyTub's servers took notice of the "hack", because SSP soon after DMed BunnyTub.

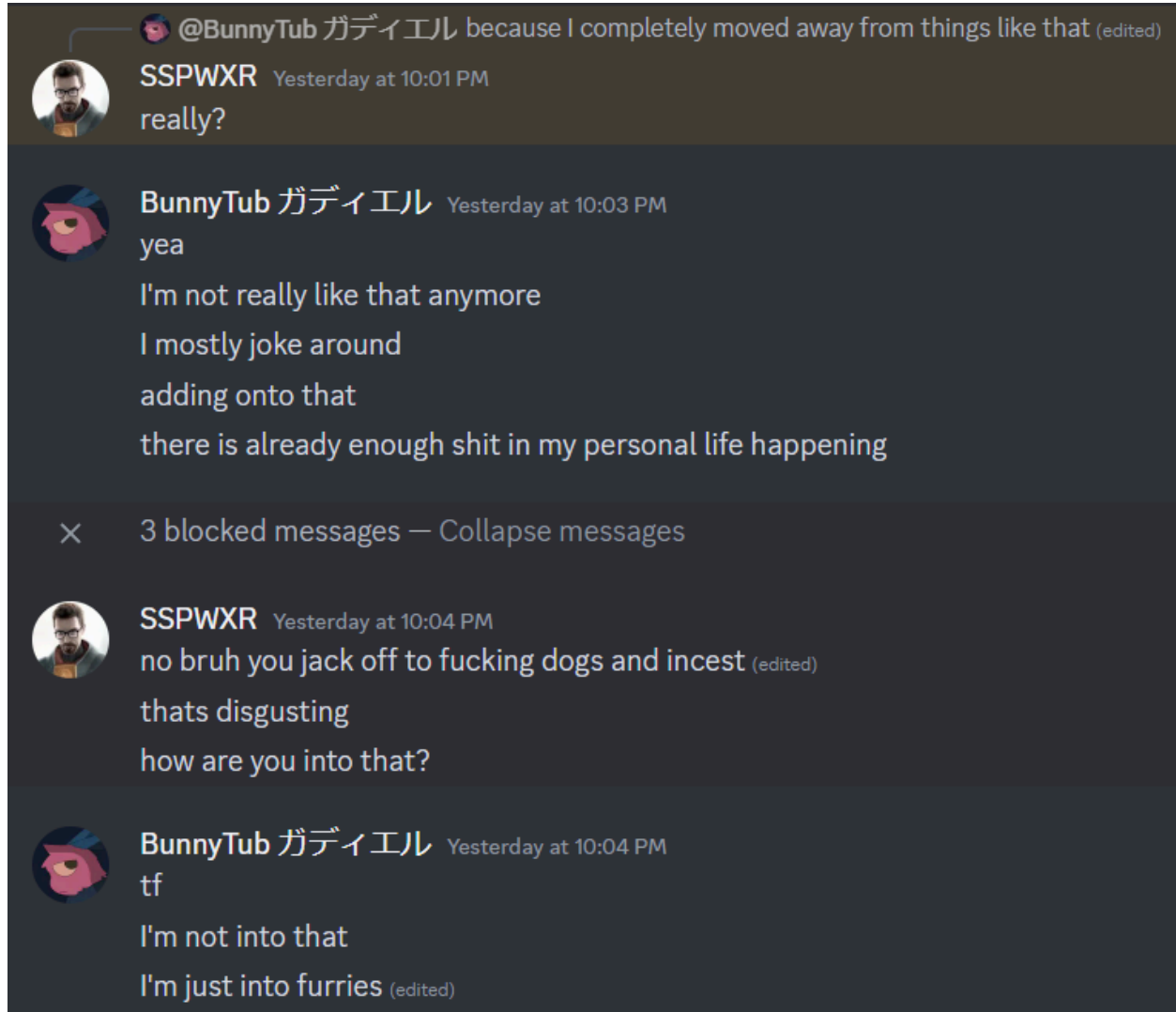

These subreddits do not contain any zoophilic content, and the subreddits are under intensive moderation, meaning even little things such as wrong type of content can get you suspended from the subreddit.

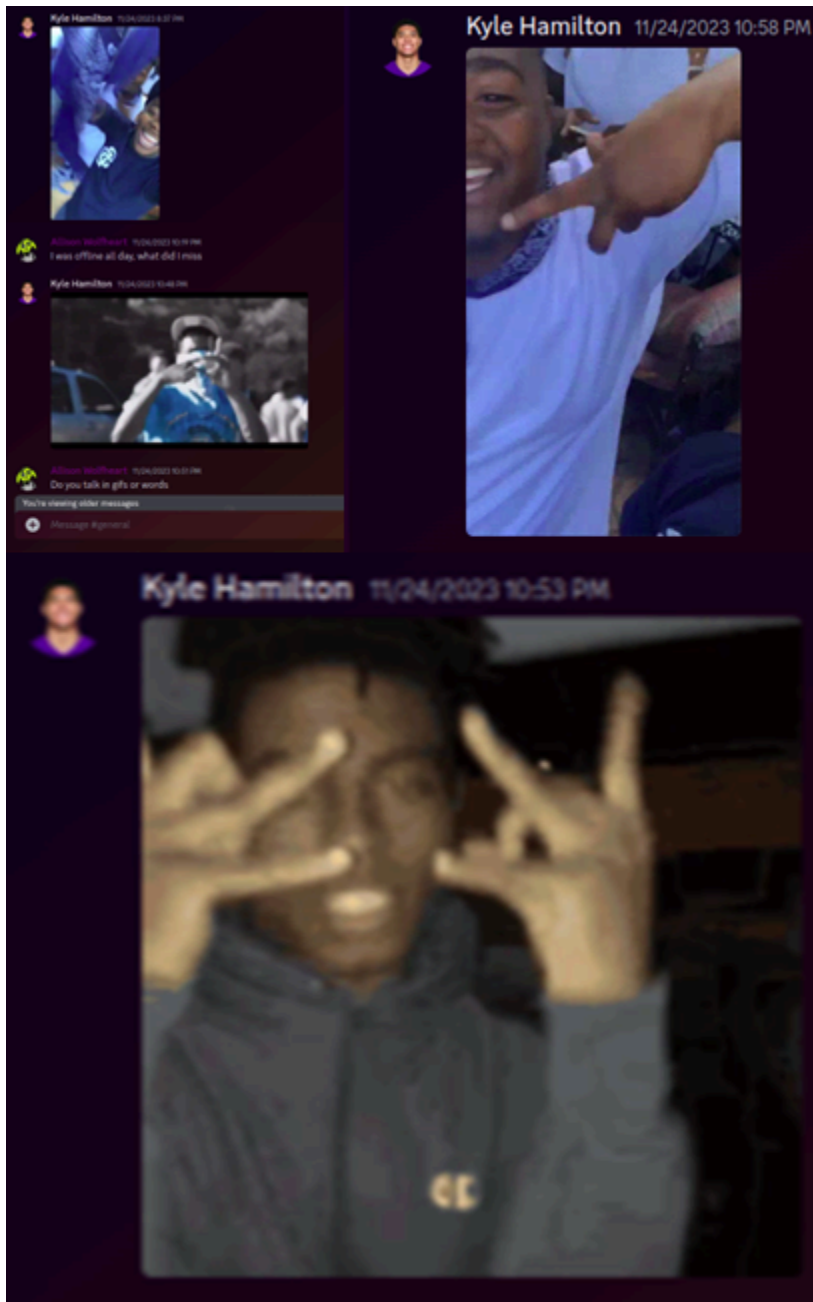

The Fallacy of Misattribution of Authority

Hyperion has negative views on CP (bannable offense). The video was up for 2 weeks, before being discovered, and removed from the platform. Before the video's removal, the policies and rules were revisited, and then modified. After this change, the video was fully removed from the platform, and was no longer viewable. However, the video was somehow viewable in a Discord embed that was posted in DM, which meant that Discord had cached the video. The crux of the issue was that KCN was salty of the ban put into effect on their moderators, and started blackmailing Pups and said they'd report the site to DigitalOcean if the video wasn't removed.

The issue was, the video appeared to be cached on Discord's side, and it was only accessible to admins who had already viewed the video for some reason. It was re-reviewed after, and deleted after rules were re-checked and verified. KCN was informed to go and stuff it about Hyperion, and Pups was dumped from the group chat.
